I. DESCRIPTION

This course will focus on a general overview of the human being from birth to death focusing on key developmental factors within the lifespan. The lifespan and the Biblical worldview will be examined within the course. **(Prerequisites: SS223).**

This is a blended class, meaning that both campus and online students take this class together. Campus students attend the classes in person, online students attend the classes via the online classroom. All interaction and assignments for campus and online students are done in the online classroom.

II. OBJECTIVES

A. General competencies to be achieved. The student will:

1. Recognize significant developmental factors within the human lifespan (PLO 1, 2, 5, 6).
2. Identify key words that highlight certain factors within the human lifespan (PLO 2, 5, 6).
3. Distinguish the differences between certain aspects of the human lifespan (PLO 2, 5, 6).
4. Explain the importance of the Biblical worldview and how it relates to the human lifespan (PLO 2, 5, 6).

B. Specific competencies to be achieved. The student will:

1. Learn to list the different stages of the lifespan (PLO 2, 5, 6).
2. Learn to identify each significant stage in the lifespan (PLO 2, 5, 6).
3. Learn to predict certain behavioral attitudes by observing significant stages in the lifespan (PLO 2, 5, 6).

4. Learn how to observe the lifespan from the Scriptures (PLO 2, 5, 6).
5. Differentiate lifespan theories from Secular Humanistic philosophy from the Biblical worldview (PLO 1, 2, 5, 6).

III. REQUIREMENTS

A. Reading Assignments

Reading Journals: (Two full pages each) the student will give the main points of the chapters read and reaction/reflection on the reading. The student will also share his/her own thoughts or opinions about the subject of the material. The student will also share how this information might be used in his/her own life (or not), and why. The personal reflection section may be written in the first person. There will be a total of **seven (6)** journals. **Each journal will be worth 25 points** (GC 1, 2, 3, 4; SC 1, 2, 3, 4).

B. Written Assignments

Critical Thinking Class Discussion: **Note: You must have a webcam in order to complete this assignment.** The student will examine a topic on the lifespan each week that will be given by the instructor, which they must comment and offer insight on posting a 5-10 minute video on. Each student will respond to at least 2 classmates with a 3-5 minute video reply. There will be a total of **seven (7)** Canvas discussions. **Each will be worth 30 points** (GC 1, 2, 3, 4; SC 1, 2, 3, 4, 5).

Key Term Assignment: The student will read, write down, and submit the key terms that are relevant to the chapter they are reading. There will be seven (7) key term assignments. **Each will be worth 20 points** (GC 1, 2, 3, 4; SC 1, 2, 3, 4).

Case Study Assignment: (one-two page maximum): The student will read the case study and identify the various stages of lifespan within the case study, as well as identifiable markers within the case study. Student is to write out the assignment in paragraph form detailing the important quality of each stage. There will be a total of **seven (7)** case studies. **Each case study will be worth 25 points each** (GC 1, 2, 3, 4; SC 1, 2, 3, 4).

C. Quizzes

There will be seven quizzes in this course. The quizzes will cover information from the lectures from the previous week and will be taken on CANVAS. They will consist of true/false, multiple choice, and fill in the blank. There will be **five (5)** quizzes. **Each quiz is worth 10 points each** (GC 1, 2, 3, 4; SC 1, 2, 3, 4).

D. Final Exam: The final exam will consist of 50 questions and will cover information presented and discussed in class. The exam questions will not be taken from the textbook unless the information was also covered in class. The final will include true/false, fill in the blank, and multiple choice (or guess). **The final exam is worth 100 points** (GC 1, 2, 3, 4; SC 1, 2, 3, 4).

E. Class Participation and Behavior

Students are expected to maintain classroom decorum that includes respect for other students and the professor, prompt and excellent attendance, and an attitude that seeks to take full advantage of the educational opportunity. Students are to refrain from using cell phones and handheld devices during class. Playing games, browsing the internet, using email, instant messaging, or text messaging, etc. are considered unacceptable when class is in session. In addition, the student will be expected to contribute to class discussions in a positive manner which shows respect for the views of others. Failure to maintain this standard may result in a **full letter grade deduction from their overall grade.**

V. MATERIALS
