## I. COURSE DESCRIPTION

A biblical study of human family relationships with an accompanying examination of contemporary viewpoints toward the same family-related subjects. The subjects studied in the course will include but not be limited to the following: gender (masculinity and femininity), singleness, marriage, family, family planning, parenting, sexual intimacy, homosexuality, divorce and remarriage, and the relationship of family to church, school, and society.

*This is a blended class, meaning that both campus and online students take this class together. Campus students attend the classes in person, online students attend the classes via the online classroom. All interaction and assignments for campus and online students are done in the online classroom.*

## II. COURSE OBJECTIVES

A. General competencies to be achieved. The student will:

1. Articulate a biblical understanding of human family relationships. (PLO\* - #1, 2, 3, 4) (A\*\* - A, B, C, & D)
2. Critically evaluate unbiblical viewpoints concerning human family relationships. (PLO - #1, 2, 3, 4) (A - A, B, & C)

3. Demonstrate greater confidence in the biblical worldview as the proper foundation of human family relationships. (PLO - #1, 2, 3, 4) (A - A, B, C, & D)

B. Specific competencies to be achieved. The student will:

1. Articulate and defend the biblical understanding of gender (masculinity & femininity), singleness, sexuality, marriage, family, and other family related issues. (PLO - #1, 2, 3, 4) (A - A, B, C, & D)
2. Critically evaluate current cultural understanding of gender (masculinity & femininity), singleness, sexuality, marriage, family, and other family related issues. (PLO - #1, 2, 3, 4) (A - A, B, & C)
3. Research and biblically evaluate current trends in practical issues concerning human family relationships. (PLO - #1, 2, 3, 4) (A - A, B, & C)

### III. TEXTBOOKS FOR THE COURSE

A. English Bible (NAS, NASB-U, NKJV, NET, ESV, or other by approval).

1. The Bible is a required textbook in every course at Calvary University.
2. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (*meaning that the translation is generally word-for-word from the original languages*), including any of the following: New American Standard (NASB, English Standard Version (ESV), New King James (NKJV), or King James (KJV). Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplemental sources.
3. Please ask the professor if you have questions about a particular translation or version.

## IV. COURSE ASSIGNMENTS AND GRADING

### A. Reading (300 points)

1. Students will read the textbook (Kostenberger/Jones) and complete a reading summary of each week's assigned chapters.
2. Students will also read articles and blog posts chosen by the instructor and complete a reading summary of each article.

### B. Response Journals (280 points). Students will document principles from the lectures and respond personally to key ideas discussed using a template provided via Canvas.

### C. Critical Analysis Presentation (200 points). Write a critical analysis of a contemporary family-related issue and present conclusions to the class.

1. Part 1: Choose a contemporary family-related issue and write a one-page explanation for why the issue is important (e.g., same-sex marriage).
2. Part 2: Identify the Biblical foundation behind the family-related issue and write a five (5) page paper establishing the Biblical teaching on the subject (e.g., Biblical doctrine of marriage).
3. Part 3: Develop a response to the contemporary family-related issue chosen and write a five (5) page paper explaining the various contemporary responses with specific examples, including the most Biblical response (e.g., affirmation, judgmentalism, tolerance).
4. Part 4:
  - a) In-class students: During the final class period, each student will make a ten (10) minute presentation of the topic, sharing their conclusions from each part, and responding to questions.
  - b) Blended (online) students: Before the final class period, each student must record a presentation via video (see #4). In addition, the student must solicit at least two questions from friends and/or family members about the topic and respond to those as well at the end of the presentation. Then, the student will upload the video to

Microsoft One Drive and share the link with the course instructor.

- D. **Local Church Leader Interviews** (220 points). Students will interview two local church leaders (i.e., pastor, elder, deacon, leading woman, youth pastor, children’s pastor, etc.) to gain insight into the most important issues facing “the family” today, as well as some of the most helpful resources these leaders recommend for strengthening families. The interviews will be documented using an assignment provided in Canvas.
- E. **Extra Credit:** The student may also receive 1 extra credit point for every verse (up to 20) recited from memory from the Book of Ephesians.
- F. **Extra Credit:** The student may also receive 20 extra credit points for having or creating a complete profile in Canvas including a 300+ word personal testimony of how s/he became a believer and how they have been disciplined since that time.
