**How does Calvary serve students who want to use their VA benefits?**

Our School Certifying Official (SCO) certifies enrollments on behalf of students who desire to use their VA benefits, using the VA's on-line system (VA ONCE).

**Who is Calvary's SCO?** Robert E. Crank, a retired Marine Corps Lieutenant Colonel, who has certified hundreds of enrollments at three different schools over two decades. Primary duty: Executive Director of Financial Aid.

**Point of contact:**

Regretfully, Calvary does not have a full-service support office for Military and Veteran students, however, we do have qualified counselors in the Financial Aid and Admissions offices.

Contact the Financial Aid office first. **Financial Aid** [finaid@calvary.edu](mailto:finaid@calvary.edu). If a Counselor is unable to answer your question directly, they will consult with our SCO, or other office, and get back to you.

**What is needed from you in order to start receiving your Education benefits?**

In order to certify your enrollment to the VA, you need to be registered for classes AND provide the Financial Aid office with a copy of your Certificate of Eligibility (COE).

If you have used your VA benefits before (at another school), the VA requires you to submit a 22-1995 (Change of Program or Place of Training).

Please send a copy of the VA's acknowledgement to our office. This will serve as "proof" of your submission, and allow us to certify your enrollment to the VA.

### **What if you add or drop classes?**

Most likely, your benefits will be impacted in some way. Please contact the Financial Aid office, as soon as possible.

**Does having all on-line classes reduce my housing allowance?** Yes (see other information)

### **Other important things you should know:**

We do not work for the VA.

The VA has policies and processes that are often different from Calvary's.

We do not compute, or have anything to do with a Housing Allowance; that is the VA's job

The VA considers our 6 month semesters and our Cycles to be non-standard terms. This can have an impact on how the VA calculates benefits; especially, the Housing Allowance and, especially, on Graduate students, who are not full-time.

### **Observations about our Cycles format and impact on a Housing allowance:**

Undergraduates need to take at least 6 hours, per Cycle, to be considered full-time.

Graduates need to take at least 4.5 hours, per Cycle, to be considered full-time.

(Note that these are "general observations; there are several factors the VA considers)

The VA uses a 30-day month; so, breaks between classes and Cycles may reduce benefits.
