I. DESCRIPTION

This course will include all aspects of establishing a biblical counseling center from the ground up. Consideration will be given to a financial operating budget, creating specific forms, becoming aware of legal implications, and becoming familiar with the day-to-day operations of a biblical counseling center in a local church. Perspective will be given to working independently or with a local church or parachurch organization. (Prerequisite: CO244)

** This course is offered in two formats: in-person and online. Students registered for in-person attend the classes in person, online students attend the classes via the online classroom. For both in-person and online students, assignments and interaction outside of the class period are done in the learning management system.*

II. OBJECTIVES

A. General competencies to be achieved. The student will:

1. Demonstrate an understanding of the nature of the local church as it relates to the counseling role within the local body of Christ. (PLO 1,4,5).
2. Identify an organizational model where the church leaders and lay leaders are motivated to be involved in a care-giving ministry. (PLO 1,4,5).
3. Identify some basic legal aspects of a counseling ministry in a local church. (PLO 1,4,5,6).
4. Investigate procedures used in interviewing, screening, and recruiting by lay leaders for a care-giving ministry. (PLO 1,4,5).

B. Specific competencies to be achieved. The student will:

1. Demonstrate how to make a one year plan to establishing a biblical counseling center in a local church or community. (PLO 1,4,5).
- 2.. Examine specific concerns in establishing a biblical counseling center in a local church, such as how to determine and arrange office space for a counseling center, financial consideration, insurance, security issues, etc. (PLO 1,4,5).
3. Demonstrate how to develop and organize a biblical counseling center in terms of specific forms, writing job descriptions, and the day-to-day oversight of the center. (PLO 1,4,5).
4. Demonstrate how to equip lay counselors in the church for biblical counseling. (PLO 1,4,5,6).
5. Demonstrate how to write counseling notes from counseling sessions. (PLO 1,4,5,6).
6. Explain and employ to securely keep confidentially counseling files in a counseling office. (PLO 1,4,5).
7. Organize biblical counseling homework assignments to be used as part of a counseling session. (PLO 1,4,5).

2. **In addition to each week's reading assignment the student shall include one or two ideas from the class lecture that will be helpful to the student in the future for ministry.**

B. Project One A-due September 19. Interview Paper, 10 pages (double space) (GC 1,2,3,4; SC 1,2,3,4,5,6,7).

The student shall interview either a pastor or counselor (staff or lay counselor) who has a counseling ministry either in a local church, counseling center or para-church ministry. A six to eight page paper will be written, describing the attitude of counseling, counseling philosophy and methodology, counseling style, background and training of the interviewee, place and use of Scripture, use of prayer, evangelism, discipleship, types of homework, primary counseling issues, referrals (to whom and under what circumstances), legal issues (forms, record-keeping, files, counseling fees, materials), counseling rooms and decor of offices (place and location), etc. Note: the above issues should be covered but not limited to. Do not interview a member of Calvary's staff, faculty or student. The interview is a fact finding project, therefore be courteous at all times and avoid debating or arguing with the interviewee. **The interview must take place on the premises where the counseling ministry takes place. Phone interview will not be accepted.** Communicate to the interviewee you would like to schedule 1 hour for the interview.

Project One B-due September 19. (May be included at the end of the interview paper as a postscript.) 5 pages

Student Interview Evaluation Paper

The student shall write an interview evaluation paper which shall include a summary overview identifying strengths and weaknesses of the counseling ministry. The paper shall also reflect personal items that both benefits and encourages the student in the ministry of counseling.

- C. **Project Two-due October 14. Topical Paper. 10 pages.** The paper shall reflect class lectures and reading material. Use Scripture to support the topics. (GC 1,2,3,4; SC 1,2,3,4,5,6,7).

The student shall write a ten-page paper by selecting one of the following topics;

- a. A Philosophy and Methodology of Establishing a Biblical Counseling ministry in a Local Church.
- b. The Role of the Pastor and Church Leadership in Identifying, Recruiting and Training lay counselors for a Care Giving Ministry.
- c. Developing and Establishing a Biblical Counseling Center for the Community. (Such items shall include legal issues, structure and organization of a center, types of centers considered, budgets, accountability, etc.)
- d. Describe a Biblical Counseling Approach That Brings About Change in the Counselee. (Explain the role of the Holy Spirit, Scriptures, homework, heart and behavior change, etc.)

IV. METHODS

A. Reading and writing assignments. (Textbooks, lectures)	100 %

V. MATERIALS

A. Bible

The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (*meaning that the translation is generally word-for-word from the original languages*), including any of the following: New American Standard (NASB, English Standard Version (ESV), New King James (NKJV), or King James (KJV). Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplement sources. Please ask the professor if you have questions about a particular translation or version.
