I. DESCRIPTION

This course provides an introduction to the basic elements of music and an overview of traditional Western classical music. The role and function of the church in the development of the art of musical expression will be examined. This course is designed for non-music majors. Non-music majors with a strong music background may substitute MU221 by taking a basic music theory placement test. (See the Music Department for permission)

- B. Out of class methods will include reading, study, practice, completion of written assignments, computer assisted theory assignments, listening, concert attendance, research, writing of projects, and preparation for oral reports.

VI. ATTENDANCE

All students must attend class. Campus students are required to attend the class in person at the scheduled time and location. All students must participate in classroom discussion through the online classroom, beginning no later than 24 hours after the class recording is posted in the online classroom. This discussion is part of the contact time for the course, and will include answering the weekly discussion question (identified in the weekly lectures) with at least a 300 word response, interacting with responses of other students and interacting with the professor. Points for participation will accrue based on successful completion, as listed below.

Excused absences include the following:

1. College field trips: Excused absences for college related activities must be arranged in advance of actually being absent.
2. Hospitalization/extreme illness: Excused absences for extreme illness will need documentation provided by a doctor, stating the specific days the student is unable to attend class.
3. Death in the family: Prior notification of the absence.

If you miss class, it is your responsibility to find out what was done, what was assigned, and to be prepared when you return to class.
