I. DESCRIPTION:

A reading seminar focusing on the writings of an important Christian thinker that has influenced or continues to influence the church. The writings will be evaluated from the perspective of biblical theology. Students will read and report on selected writings of the thinker. This course may be taken four times for credit as different Christian thinkers are covered. (Prerequisite: RP100 and Junior class standing or permission of the professor) (ILO- #1, 2, 3)

II. COURSE OBJECTIVES:

A. General competencies to be achieved: You will be able to . . .

1. Articulate the cultural influences on the thinking of the Early Church Fathers. (PLO- #2) (A- A & B)
2. Summarize the biblical and theological perspectives of the Early Church Fathers. (PLO- #1, 2, & 3) (A- A & C)

Our Mission: "...to prepare Christians to live and serve in the church and in the world according to the Biblical worldview."

3. Classify the types of literature used by the Early Church Fathers for expressing their theology. (PLO- #1, 2, & 4) (A- A & B)
4. Critically evaluate selected writings of the Early Church Fathers. (PLO- #1, 2, 3, & 4) (A- C)

B. Specific competencies to be achieved: You will be able to . . .

1. Articulate the cultural influences which shaped the theology and writings of the Early Church Fathers. (PLO- #1, 3, #4) (A- A & B)
2. Critically evaluate selected writings of the Early Church Fathers. (PLO- #1, 2, 3, &4) (A- C)
3. Demonstrate the ability to accurately communicate the theology and thinking of selected Early Church Fathers. (PLO- #1, 2, 3, & 4) (A- C)

III. REQUIREMENTS

***Note:** Specific instructions for each assignment are posted in Canvas.

A. Read the course textbook and make ask significant questions.

1. Read the textbook according to the Class Schedule.
2. Write a significant of the text material concerning either the Early Church Father or his writings.
3. Note: The student assigned to make a presentation with answer each of the questions the other students have asked about that Early Church Father or his writings.

B. Develop a Backgrounds Chart of the times of the Early Church Fathers.

1. Research the historical events which occurred during the lives of the Early Church Fathers.
2. Present the findings from this research in the form of a chart which shows the historical events which influenced the Early Church Fathers, to include the following.
 - a. Significant world events.
 - b. Significant Church events.
 - c. Authors – when they lived.

C. Study a selected Early Church Father and write a critical paper.

1. Study the life and selected writings of a specific Early Church Father.
2. Write a 2500-word essay about the author and his writings that includes the following.
 - a. analysis of his life identifying the significant influences upon his thinking.
 - b. discussion and evaluation of his specific theological perspectives as presented in his selected writings.
 - c. an assessment of the impact of his writings upon the Church.

D. Make a presentation of your conclusions concerning the selected Early Church Father.

1. This presentation is not to be the mere reading of your paper, but it is to be a verbal highlighting of your findings (e.g., envision making this as a presentation to a church group or in a seminar setting).
2. A PowerPoint presentation must accompany the presentation.
3. This presentation should be at least 30 minutes in length.
4. During the presentation, the presenter must answer the questions the other students submitted concerning the Early Church Father or his writings.

E. Write significant questions about each day's additional lecture material.

1. Following the instructor's presentation of additional theological material concerning the Early Church Fathers, submit a significant question which the material raised.

IV. METHODS

A. Presentation:

1. **In-class methods:** listening to lectures, participating in class discussions, research, writing, and making presentations.

***About Class Attendance:** Research consistently demonstrates that class attendance and active participation correlate to higher performance on course assessments.

***About Classroom Use of Media:**

-**Computing devices** are permitted during the lecture and class discussion sessions for the sole purpose of taking notes. Use of these devices to access the Internet, make telephone calls or video calls, text messaging, updating social network services, etc. is not allowed, let alone very distracting to other students.

-**Cellphones / smartphones** may only be used in an emergency, and in those situations the student may take the call but must leave the room and not return until the next break out of courtesy to fellow classmates.

***About Note Taking:** Students are expected to take notes during each class. Significant peer reviewed studies continue to demonstrate that notes taken by hand are understood better and remembered longer than those taken with a computer. Computer use which is a distraction to others (i.e., noise, blocking the screen, displaying non-class related material, etc.) is not allowed.

2. **Out-of-class methods:** observation, evaluation, and sermon preparation.

***About written assignments:** Unless directed otherwise, all written assignments must follow the Turabian style according to *A Manual for Writers of Research Papers, Theses, and Dissertations*, 8th edition and the Calvary Style Guide, 2019 update.

B. Grading:

- ***About Late Assignments:** Assignments turned in late will be lowered **5% each class day** it is late.
- ***About Plagiarism:** Plagiarism is defined as copying any part of a book or essay without identifying that source. This also includes taking another person's ideas and presenting them as your own without identifying the source. Any assignment that includes plagiarism will receive a **zero (0) grade**. (**Note:** Turn-It-In.com will be used to verify plagiarism.)

V. MATERIALS

A. Required:

1. English Bible (NAS, NASB-U, NKJV, NET, ESV, or other by approval).

-The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (*meaning that the translation is generally word-for-word from the original languages*), including any of the following: New American Standard (NASB, English Standard Version (ESV), New King James (NKJV), or King James (KJV). Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplemental sources. Please ask the professor if you have questions about a particular translation or version.
