### I. Description

The fourth Gospel is analyzed to distinguish its unique features which traditionally have placed it in a category distinct from the viewpoint of the Synoptics. The doctrinal, devotional, and prophetic aspects are emphasized. (Prerequisite: BI115)

*This course is offered in two formats: in-person and online. Students registered for in-person attend the classes in person. Online students attend the classes via the online classroom. For both in-person and online students, assignments and interaction outside of the class period are done in the learning management system.*

### III. Textbooks

- A. The Bible: The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (*meaning that the translation is generally word-for-word from the original languages*), including any of the following: New American Standard Bible (NASB), English Standard Version (ESV), New King James Version (NKJV), or King James Version (KJV). Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplemental sources. Please ask the professor if you have questions about a particular translation or version.

### IV. Assignments

- A. **Reading** (240 points possible; 30 each week): The student will read the Gospel of John and two shorter commentaries (see “Textbooks” above) according to the schedule provided in Canvas.
- B. **Weekly Quizzes** (240 points possible; 30 each week): The student will take a weekly quiz to reinforce the key ideas presented in the classroom discussions.
- C. **Study Projects** (420 points possible; 60 each week): To reinforce the skills learned in BI115 Hermeneutics and Bible Study Methods, the student will have weekly study projects that must be done in the following order:

1. **Read the Gospel of John** (see separate “Reading” assignment): The student will read the assigned passage in John BEFORE reading the textbooks.
2. **Read Textbooks:** The student will read the correlating sections in the textbooks AFTER completing part 1.
3. **Make Observations:** The student will make observations about John according to the specific instructions provided in Canvas.
4. **John Chart:** Fill in the John Chart (see IV.D. in syllabus) based on the work done in part 3 (i.e., "Make Observations").

D. **Overview Chart** (100 points possible): Complete a chart of the entire Gospel of John according to the format explained in class and in Canvas.
