DESCRIPTION

This degree requirement includes an assessment of the student's cumulative biblical and theological studies through a doctrinal beliefs statement and oral defense that will prepare the student for future ministry opportunities or entrance into seminary upon graduation.

This is a blended class, meaning that both campus and online students take this class together. Campus students attend the classes in person, online students attend the classes via the online classroom. All interaction and assignments for campus and online students are done in the online classroom.

OBJECTIVES

TEXTBOOKS

The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (*meaning that the translation is generally word-for-word from the original languages*), including any of the following: New American Standard (NASB, English Standard Version (ESV), New King James (NKJV), or King James (KJV). Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplemental sources. Please ask the professor if you have questions about a particular translation or version.

REQUIREMENTS

- A. Review past coursework in Systematic theology I, II, III to prepare for the project.
- B. Write a doctrinal beliefs statment (a paper of 10 single spaced typed pages).
- C. This first draft will be submitted to the Program Director at least one cycle prior to their graduation (by the end of cycle 2 if the student anticipates graduation at the end of cycle 3 and by the end of cycle 4 if the student anticipates graduation by the end of cycle 5).
- D. The first draft will be submitted through Canvas.
- E. The student will then meet with the Program Director to defend his/her doctrinal belief statement (in cycle 3 if the student anticipates graduation in December and in cycle 5 if the student anticipates graduation in May). Failure to complete this assignment will lead to a delay in graduation from Calvary University.
- F. The final draft of the Doctirnal statement will be submitted through Canvas.

METHODS OF ASSIGNMENT

- A. Independent work and study
- B. Consultation with instructor (if needed)
- C. The student will submit the complete first draft to the Department Director. This draft should be well proofed and in excellent form. This draft will be read prior to the oral defense. This will allow the student time to receive feedback and corrections, make needed corrections, and to prepare for the oral defense of the statement of doctrinal beliefs.
- D. Defend doctrinal belief statement to Department Director. The student will be questioned on all areas of doctrine covered in their statement. Areas of possible weakness and areas that need clarification will be probed.

E. Sumission of the final, polished product. The Program Director has the right and responsibility to return the final draft to the student for additional corrections until it is of acceptable proofed quality. Graduation may be postponed if the final draft is not returned in a timely manner. The completed final draft must include the Title page, Table of Contents, and Statement of Faith.

Policies

Paper must follow the Turabian style according to *A Manual for Writers of Research Papers, Theses, and Dissertations*, 8th edition and the Calvary Style Guide, 2019 update.

Late Assignment: Will not graduate

The Doctrinal Beliefs Statement is a critical document for a student and future ministry. The requirements and guidelines necessary for adequate preparation and presentation are contained in this section. The student is expected to follow all of these and submit the written materials no later than the above stated deadlines.

II. Doctrinal Beliefs Statement Quality and Length

This requirement is for graduation and ministry. It should reflect careful study and clear understanding of the doctrines, and should be in the student's own wording and reflect his/her position on these areas of theology.

- A. The quality is reflected by accuracy pf explanation and Scripture citation. Each area of belief and commitment selected will indicate importance and relevance.
- B. The length is a minimum of 10 pages single spaced typed pages. The number of areas for examination plus one's ability to express accurately and precisely will affect the length. It is important to remember two aspects: 1) it is not necessary to be wordy, and 2) you will be able to explain details in the oral defense.
- C. The Doctrinal Beliefs Statement must be submitted no later than the due date.

III. Doctrinal Beliefs Statement Oral Defense

- A. The Program Director will schedule a date for the defense.
- B. The student is responsible to explain and defend any written materials, and responsible for all questions relative to the theologies and issues in the official guidelines for the Doctrinal Beliefs Statement.
