I. DESCRIPTION

PS690 Thesis – The student will produce an original paper of 50 to 75 pages demonstrating his ability to (1) do scholarly research on an approved topic, (2) express himself in a proper literary style, and (3) defend the thesis in a consistent theological and intellectual manner. (Fee: \$95) [ILO- 1, 2, & 3]

PS691 Thesis Continuation – This course keeps the student's final product proposal current in the event the student is unable to meet the deadlines for the first draft, final draft, or final/library copy. Final Product Continuation may only be taken two times. (Fee: \$100) [ILO- 1, 2, & 3]

II. OBJECTIVES

 - 2. Demonstrate graduate-level ability with the Biblical languages, the Bible, and Theological analysis and synthesis. (PLO- #1, 2, & 4) (A- B, C, D, & F)
 - 3. Defend a graduate-level thesis on a ministry-related topic. (PLO- #1, 2, 3, & 4) (A- A, B, C, D, E, & F)

III. MATERIALS

A. Required:

- 1. Bible.
 - -The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (*meaning that the translation is generally word-for-word from the original languages*), including any of the following: New American Standard (NASB, English Standard Version (ESV), New King James (NKJV), or King James (KJV). Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplemental sources. Please ask the professor if you have questions about a particular translation or version.

IV. REQUIREMENTS

***Note**: Specific instructions for each assignment are posted in Canvas.

A. Select a ministry-related graduate-level research topic – Proposal.

- 1. Consult with the Course Instructor to identify an acceptable research topic.
- 2. Submit the Thesis Proposal form and an initial bibliography.

B. Present a Thesis research proposal – Syllabus.

- 1. Following the process learned in RT615, submit a Thesis Syllabus.
- 2. This Thesis Syllabus will be approximately 2,500 words plus a bibliography.

C. Research and write chapters 1 & 2 of the Thesis.

- 1. Submit the draft of Chapter 1 of the Thesis. This chapter will demonstrate the need for research on the ministry-related topic. The general method of inquiry must also be outlined and explained in this chapter.
- 2. Submit the draft of Chapter 2 of the Thesis. This chapter will constitute the biblical and theological study of the selected topic.

D. Research and write chapters 3, 4, & 5 of the Thesis.

- 1. Submit the draft of Chapter 3 of the Thesis. This chapter will reveal the research findings, analysis, and conclusions of others pertaining to the research topic and your critique of the same.
- 2. Submit the draft of Chapter 4 of the Thesis. This chapter will present your answer to the research question / problem. It will incorporate your conclusions and recommendations in a well-reasoned application to a ministry-related context.
- 3. Submit the draft of Chapter 5 of the Thesis. This chapter will present in summary fashion your thesis and argument. It will also include suggestions for further study.

E. Prepare the other elements of the Thesis.

1. Submit the other elements of a Thesis: Title page, Abstract page, Contents page, List of Illustrations page (optional), List of Tables page, (optional), Abbreviations page, Appendices (optional), and Bibliography.

F. Submit the final copy of the Thesis.

- 1. Following the course instructor's review of the Draft of the Thesis, you will make all recommended changes (i.e., to assignments C, D, & E).
- 2. Submit the final revised copy of the Thesis.

V. METHODS

- **A.** There are no in-class aspects to this course other than as-needed conferences with the course instructor concerning the course assignments.
- **B. Out-of-class methods** include research, analysis, synthesis, and writing.
