I. DESCRIPTION

An introduction to the various areas and aspects of psychology and a preparatory course in basic psychological concepts dealing with man's psychophysical development. Psychology is interpreted in the light of biblical teachings, and the course is aimed at helping the student understand his own behavior as well as that of others.

** This course is offered in two formats: in-person and online. Students registered for in-person attend the classes in person, online students attend the classes via the online classroom. For both in-person and online students, assignments and interaction outside of the class period are done in the learning management system.*

II. OBJECTIVES

III. REQUIREMENTS

- A. READING: Read each chapter completely and thoroughly.
- B. DISCUSSION POSTS: Write a 700 word essay on a topic in the reading each week and compare it to a biblical worldview.
 - a. Your report should contain an analysis and evaluation of the topic.
 - b. You will then read two other classmates essays and write a peer review.
- C. Write a Topical Paper regarding an issue discussed in class.

This Research Paper should be 10 pages in length with 8 sources. The bible is allowed to be one source.

More information will be discussed in class.

D. Perspective Psychological Paper

After you have read chapter 10 in the textbook, reflect on your own personal growth and development, and write a six page double spaced history of your pilgrimage toward wholeness.

E. EXAMINATIONS: There will be two exams over the content discussed in class.

IV. METHODS

Lectures, discussions, reports, reading

Students missing more than 4 class sessions automatically receive an “EA” (excessive absence) or failing grade for the course. Online students will be marked present for each class after they watch the class session video and answer the questions that were discussed in class.

VI. ACADEMIC STATEMENTS

Other translations and versions based on dynamic equivalence (*paraphrases, and thought-for-thought translations like NLT and NIV*) may be used as supplemental sources. Please ask the professor if you have questions about a particular translation or version.
