### **COURSE DESCRIPTION**

The Ph.D. candidate will write pages 76-150 of the dissertation. (See Finances section for fee associated with this course.)

### **COURSE OBJECTIVES**

**The student will:**

- 1. Research the topic of his/her dissertation by reading books, journal articles and dissertations (PLO 5 A 1, 3)**
- 2. Write and finish the first 75 pages of his/her dissertation (PLO 5 A 3)**
- 3. Meet with his/her dissertation advisor and reader to discuss his/her dissertation (PLO 5 A 2, 4)**
- 4. Make changes/revisions to his/her dissertation when advised by the dissertation advisor, reader and Ph.D. director (PLO 5 A 2, 4)**

## **REQUIRED TEXTBOOK**

The Bible is a required textbook in every course at Calvary University. To facilitate academic level study, students are required to use for assignments and research an English translation or version of the Bible based on formal equivalence (meaning that the translation is generally word-for-word from the original languages), including any of the following: New American Standard (NASB), English Standard Version (ESV), New King James Version (NKJV), or King James Version (KJV). Other translations like NLT and NIV may be used as supplemental sources. Please ask the professor if you have any questions about a particular translation or version.

## **REQUIRED: ORIGINAL LANGUAGE BIBLE STUDY SOFTWARE (Accordance, Bible Works, Logos)**

Students are required to have digital resources to engage Biblical study in the original languages, including but not limited to *Biblia Hebraica Stuttgartensia (BHS)*, *Nestle Aland 28 (NA28)* – both including critical apparatus; *Septuaginta (LXX)*, *a Greek Lexicon of the New Testament and Other Early Christian Literature (BDAG)* by Bauer, Danker, Arndt, and Gingrich; *Hebrew and Aramaic Lexicon of the Old Testament (HALOT)* by Koehler and Baumgartner.

## **ASSIGNMENTS**

Assignment #1: Write a detailed outline of pages 76-150 of your dissertation (200 points)

Assignment #2: Meet with your advisor and reader of your dissertation in Microsoft Teams to discuss the outline/argument of the next section of your dissertation (100 points)

Assignment #3: Write pages 76-150 of your dissertation (600 points)

Assignment #4: Meet with your advisor and reader of your dissertation in Microsoft Teams to discuss pages 76-150 of your dissertation and get their approval and/or make revisions (100 points)
